Deputy Clerk's Report

Actions and updates since the last Amenities Committee meeting on 22nd April 2025.

- a. **Trees at the Playing Field.** The TPO is about to be applied for by the Clerk for the work to be carried out. The rest of the work on the trees will be carried out when this has been approved.
- b. **CCTV at the Playing Field.** This has now been installed and Ali has received the Licence Agreements that will be discussed at the Full Council meeting in June.
- c. **Playing Field Picnic Benches.** The picnic benches have been delivered and so have the chains, ground anchors and padlocks. This has been added to the Caretaker's To Do List and will be installed shortly.
- d. **Football Goal Posts.** The Contractor visited the Playing Field and met with the Clerks and Caretakers. The field was measured by the robot (see Photo 1. Below) and marked out (see Photo 2.). The Caretakers marked by removing some turf where the holes were to be dug. The Goal Posts (currently stored in the Changing Rooms) will be installed shortly.
- e. **Happy to Chat Benches.** The Deputy Clerk has found a sign and is seeking quotes. Upon speaking to the Caretaker to which benches are used most, two benches have been picked, one in shade and one that gets sunlight (see Photo 3. and Photo 4.)

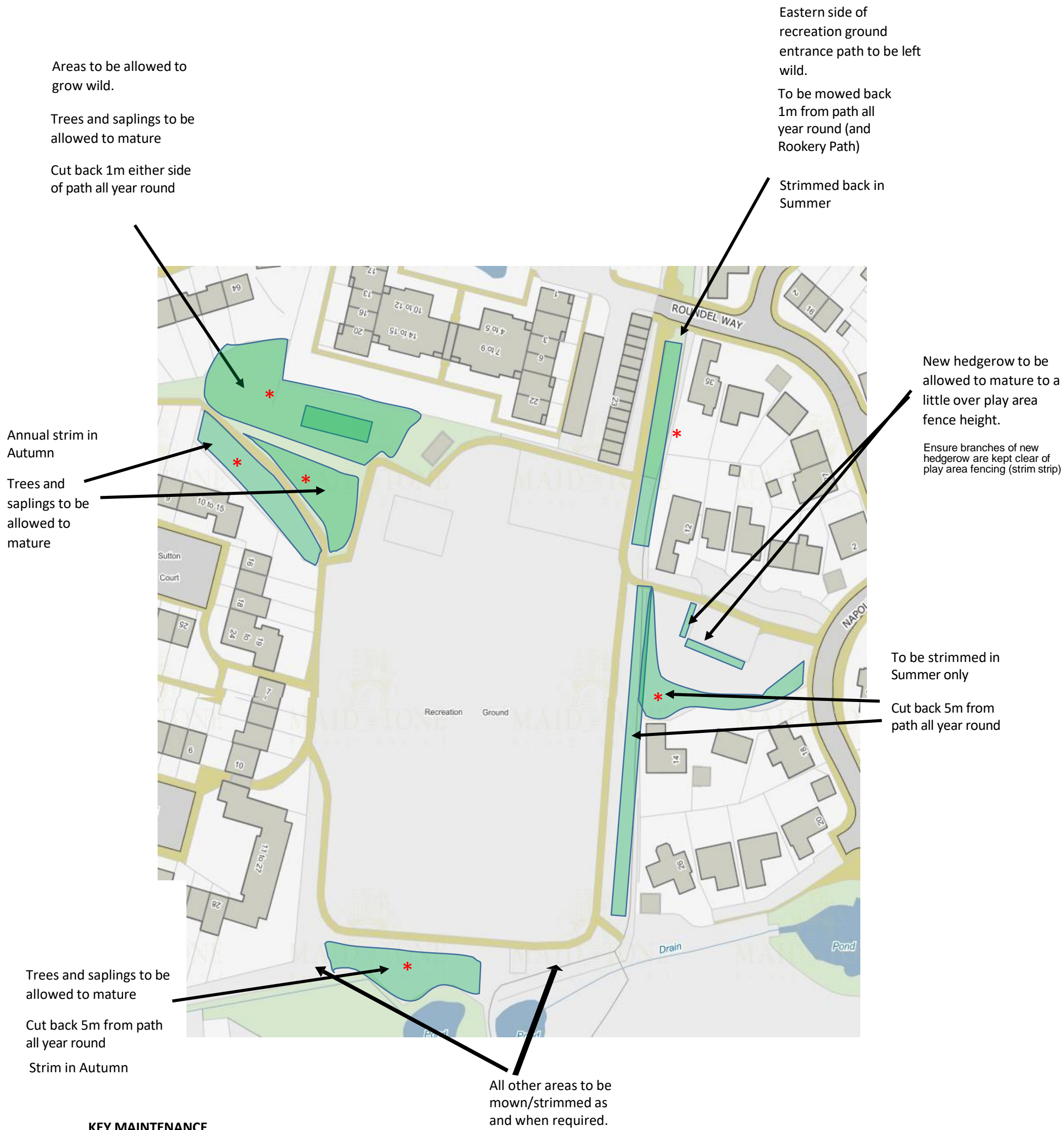

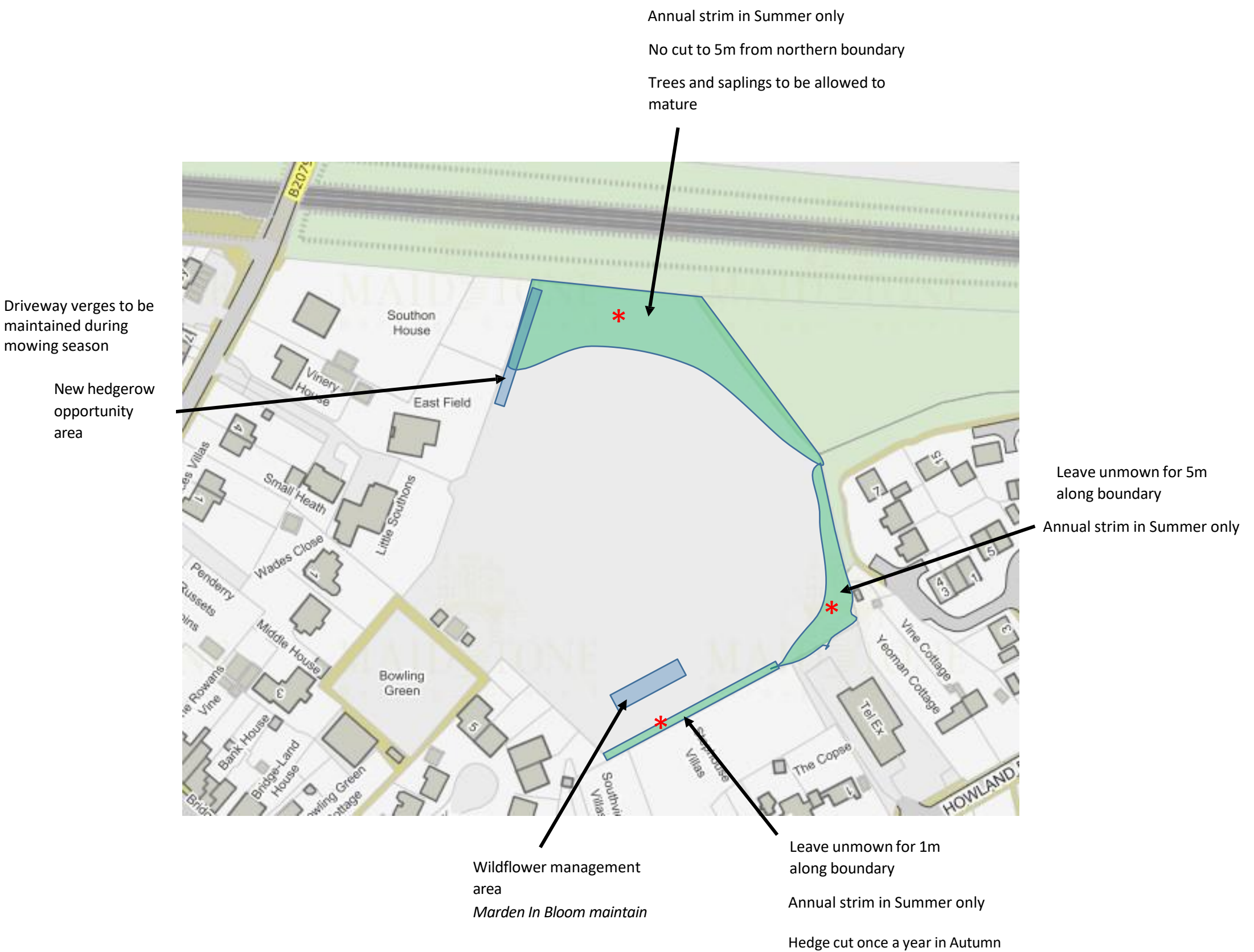
MARDEN PLAYING FIELD MAINTENANCE STRATEGY (Version 4)



KEY MAINTENANCE

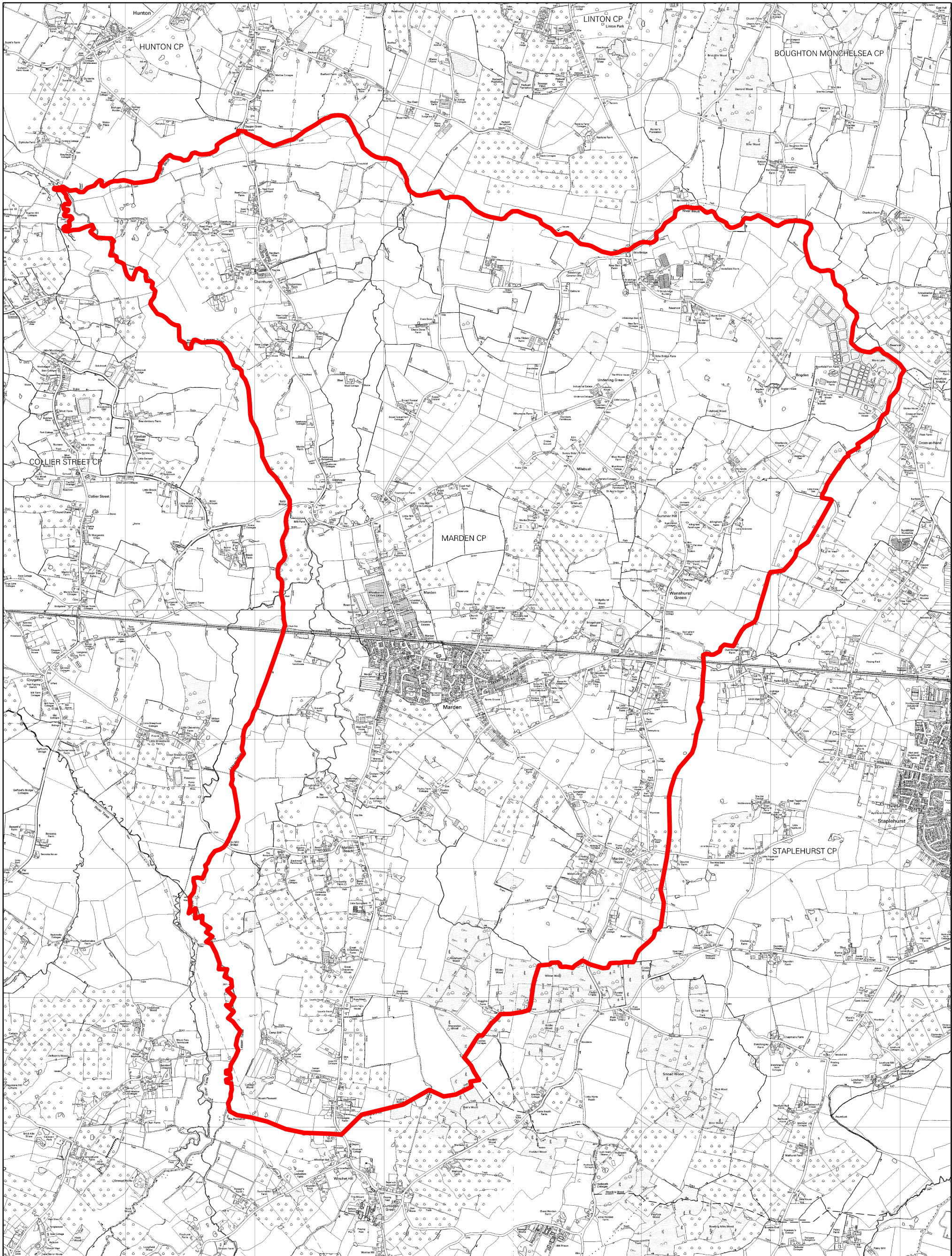
- All remaining areas to be cut back to recreational grass standard all year;
- All footpath edges to the strimmed/ cut to recreational grass length.
- Area around Changing Rooms to be strimmed and cut – kept low.
- Areas with * not to be strimmed or mown in May (“No Mow May”)

MBC are awaiting delivery of new litter bins by the end of June. Once they have a confirmed delivery date, they will audit all their litter bins to relocate or replace. They have said they will ensure this litter bin is part of this work.
